Pakistan Audit & Accounts Academy (PAAA)

1. Introduction

Pakistan Audit and Accounts Academy (PAAA) is the Auditor General of Pakistan's premier training institution. With four regional academies situated in Karachi, Peshawar, Islamabad and Quetta, and its head office in Lahore, the Academy boasts a varied and prolific training profile. It offers the long-term Specialized Training Program (STP) for newly inducted probationary officers (BS-17) allocated to Pakistan Audit &Accounts Service (PA&AS), as well as shorter trainings in various areas of public sector finance to employees of the department of the Auditor General and other government agencies as well.

The Academy's mission is to prepare and develop the department's human resource in their professional capacities as accountants, auditors and finance managers, as well as to develop capacity of public sector institutions in public sector financial management, data analytics e.g. use of SAP, budgeting, procurement, etc.

PAAA's platform is also used for liaison with other SAIs for INTOSAI training workshops and working groups' meetings. The Academy's infrastructure and resources have been used to conduct courses for the Organization of Islamic Countries (OIC), ASOSAI, ECOSAI, IDI and other capacity development initiatives.

2. Message from the Auditor General of Pakistan

PAAA is mandated by the DAGP to promote capacity building of public functionaries in the domain of public sector auditing, accounting, emerging sciences and allied technological skill sets across Pakistan. On the one hand, PAAA imparts specialized training to young entrants into PA&AS as well as undertaking continued professional development of middle tier and senior officers of DAGP. On the other hand, PAAA provides subject/needs specific training courses to a wide variety of



audience, covering not only audit and accounts offices but allied sister organizations based on

demand/requests. Through PAAA the DAGP is striving to introduce new and contemporary knowledge skill sets into government officers in emerging areas, such as data analytics, environmental sciences, climate change, information systems, etc. all with the broader objective of improving the public service delivery at government offices across the country.

3. Message from the Rector

PAAAprovides both induction level training and in-service training to the officers and officials of the DAGP as well as to provide policy input to the higher management.

The Academy strives to make the human resource of DAGP and other public sector institutions to upgrade their knowledge of the principles and techniques of modern finance, accounting, information technology and auditing. The Academy is also responsible for conducting continuous professional development courses at local and international level. To fulfill this responsibility, PA&AA is reinvigorating its trainings by including new and emerging audit areas and use of technology in auditing.

4. Specialized Training Program (STP)

One of the key academic features of PAAA is conducting of specialized training for PA&AS probationary officers. Every year having qualified the CSS exams and after completion of common training program at CSA probationary officers of PA&AS join PAAA for domain specific intensive training. This training course named STP is an eleven month vigorous training exercise aimed at the professional capacity building of the probationary officers in such manner that they can serve in challenging audit & accounts assignments upon completion of subject training.

At present the 50th STP Course is underway. A total number of 15 probationary officers from PA&AS are taking part in the subject training.

5. Mid-Career Management Course (MCMC)

The Mid-Career Management Course is a mandatory training program required for promotion of officers of the Government of Pakistan from Grade 18 to Grade 19. The Course has a compulsory Domain Specific component where officers of the Pakistan Audit and Accounts Service are required to undergo intensive training at PAAA for four weeks in public financial management courses.PAAA has recently conducted six rounds of domain-specific training this far.

6. Short Courses Programme

PAAA conducts a multitude of specially designed, requirement based short courses to cater for the capacity building needs of accounts and audit offices across the country. As per Approved Annual Training Program (ATP), short courses are carried out throughout the year across all the regional offices of PAAA as well as at its HQ Lahore.

Apart from providing training services to Audit &Accounts offices, PAAA also conducts trainings requested by other government bodies and departments. Organizations that have requisitioned PAAA for training include, KP Government, Higher Education Department Government of the Punjab etc. A list of all scheduled courses for the next year can be viewed on our website www.paaa.gov.pk. Training costs are applied as per government rules and instructions of Finance Division issued on the subject.

7. Course Design & Material Development Unit

The Course Design and Material Development Unit (CD&MDU)'s main objective is to make PAAA a leading professional research and training institute in the disciplines of Financial Management, Accounting and Auditing by developing new skilled-based short courses and updating the existing ones to enhance the capacity of all levels of management in the DAGP as well as other organizations, bodies of the Federal and Provincial governments. This also includes designing of courses for other public sector institutions in the areas of public sector financial management.

The role of PAW is unique as it has been conducting the International Intensive Training Programs (ITPs) in Performance Auditing for the last four decades for the audit managers of various Supreme Audit Institutes (SAIs). The audit managers are nominated each year by their respective SAIs to participate in the International Intensive Training Program (ITP) in Performance Auditing at Lahore. So far, we have trained *504 foreign participants from 45 countries*. Besides Intensive Training Program, workshops and seminars under the platform of ECOSAI have also been organized by this wing.
